

2026 Bay-Delta Science Conference Sponsorship Terms

By choosing the selected sponsorship option for the 2026 Bay Delta Conference (Conference), Sponsor agrees to the following:

A. Terms & conditions:

1. Sponsor agrees that the selected sponsorship option is nonrevocable by Sponsor.
2. Sponsor grants the Council and Events Enterprises, Inc. (Events) a limited, irrevocable, non-exclusive license to use the Sponsor name and/or logo, subject to the reasonable formatting requirements of Sponsor, to list Sponsor in the Conference program, to acknowledge the sponsorship, and to provide the other benefits that correspond with the sponsorship level.
3. Sponsor shall indemnify, defend, and hold harmless the Council, its officers, employees, and agents from and against any and all claims, demands, damages, losses, liabilities, costs, or expenses arising out of or related to any of the following:
 - a) Sponsor's participation in the Conference;
 - b) Sponsor's products, services, materials, or activities related to or arising from Sponsor's participation in the Conference;
 - c) Any act or omission, related to or arising from the Sponsor's participation in the Conference, of Sponsor, its employees, officers, agents, contractors, representatives, or others authorized to act on the Sponsor's behalf, whether individually and collectively;
 - d) Any alleged infringement of intellectual property rights by Sponsor's materials or actions.

To the maximum extent permitted by law, the Council shall not be liable for any indirect, incidental, special, or consequential damages related to this Agreement or the sponsorship.

This entire provision shall survive the termination and expiration of this Agreement.

4. Sponsor agrees that Sponsor and its employees, officers, agents, contractors, representatives, and others authorized to act on the Sponsor's behalf shall comply with all applicable federal, state, and local laws, regulations, and policies related to its sponsorship activities and participation in the Conference.

5. Sponsorship is subject to the written approval of the Council, which shall be at the discretion of the Council. If granted, the Council will provide written approval to Events within seven days of Sponsor completing the transaction for the selected sponsorship. Events will contact Sponsor to confirm approval within three business days of receipt.
6. If Sponsor or any of its employees, officers, agents, contractors, representatives, or others authorized to act on the Sponsor's behalf fails to comply with this Agreement, the Council may terminate the sponsorship and revoke all associated benefits. Notice of termination will be provided to Sponsor in writing.
7. The Council may terminate the sponsorship for any reason by written notice to Events and Sponsor.
8. Sponsor acknowledges and agrees that the Council's authorization of any sponsorship does not suggest or convey the Council's approval, endorsement, certification, acceptance, or referral of any product or service of Sponsor. Sponsors shall not be authorized to act on behalf of the Council.

B. Payment Terms and Policy

1. Payments are to be made to Events. Events will invoice Sponsors after all parties have signed the Sponsor Agreement. Payment is expected within 30 days after receipt of the invoice.
2. Sponsor may not cancel the sponsorship at any time after completing the transaction for the selected sponsorship. No refunds will be issued to Sponsor for termination pursuant to paragraph 6.
3. Sponsor acknowledges that a single sponsorship payment may be treated as separate payments and accounted for as such. Sponsorships funds will be used by Events in accordance with agreement DSC25926. Sponsorship funds may be allocated and used as such by Events at any time. A sponsorship is not deductible as a contribution to an exempt organization as described in Section 501(c)(3) of the Internal Revenue Code.
